



Bolton serves in many leadership roles at ICBA. He is chairman of the ICBA Executive Committee and the board of directors. He is a member of ICBA's Federal Delegate Board and its Policy Development and Nominating committees. He is a member of ICBA's ThinkTECH Selection Committee and serves as the Executive Committee liaison to the Bank Services Committee.

Bolton has previously served on the board of directors as chairman of the Bank Education Committee and has also served on several other committees.

A second-generation community banker, Bolton is also active at the local level. He served as past chairman of the Alabama Young Bankers known as Leadership Community Bankers. He serves on the Legislative Committee of the Mississippi Bankers Association. He is an elected member of the Red Bay, Ala., City Council and is an appointed member of the Franklin County Community Development Commission. He previously served on the Atlanta Federal Reserve Board's Community Depository Institution Advisory Council. Bolton has a Bachelor of Business Administration from the University of West Alabama. He is a graduate of the Barret School of Banking in Memphis, Tenn. He lives in Red Bay, Ala., with his wife, Julie. They have two daughters, a son, and a son-in-law.

In 1987, after commanding an M-1 Armor Battalion in Germany for two years, he was selected to serve as the chief of the International History Division of the Department of History at the United States Military Academy.

Scott has published five books including The Big Red One: America's Legendary 1st Infantry Division from World War I to Desert Storm and his latest book, Jacob L. Devers: A General's Life.

Melanie Hall is the Commissioner of the Montana Division of Banking and Financial Institutions. She provides the overall leadership to the Banking Division, which is responsible for the supervision of all state-chartered banks and state-chartered credit unions.

In addition, the division licenses and examines over 2000 non-bank financial entities including mortgage lenders, mortgage servicers, mortgage brokers, consumer loan companies, sales finance companies, deferred deposit lenders, and escrow businesses. The Division is also responsible for processing all consumer complaints by Montanans against regulated and unregulated providers of financial services.

Commissioner Hall obtained her B.A. in Economics from Eckerd College in St. Petersburg, Florida, and her Juris Doctor from Tulane Law School in New Orleans, Louisiana. She is the Chair of the Board of the Conference of State Bank Supervisors and is the past Chair of the CSBS Education Foundation Board.

She also serves on the St. Peter's Hospital Foundation Board of Trustees.

Jeff Thompson is a Vice President, Managing Consultant for UBB Compliance Services. His career began in 1987 as a Bank Examiner with the Office of the Comptroller of the Currency. WHITEFISH

GLACIER NATIONAL PARK

The scenic wonder of Glacier National Park is located 25 miles from Whitefish. Travel the famed Goingto-the-Sun Road in a vehicle or explore trails from horseback or your own feet! There are over 700 miles of hiking trails to experience for various levels of fitness and time. For road and trail information, stop at Apgar Visitor Center, open daily mid-May to mid-October.

Entrance Fees: \$35/7-day permit | Annual pass/\$70

Entering at West Glacier, Camas Road or Polebridge: Through Sept 11, 2022, entering Glacier at these locations requires a park pass, as listed above, PLUS a \$2 Vehicle Reservation or a Service Reservation (lodging, tours). Vehicle reservations are available the day before the effective date at recreation.gov. Visitors are encouraged to secure these reservations prior to arrival. For more info visit nps.gov/glac/

*Vehicle Reservations are not required to enter at the St. Mary Entrance, however a reservation is needed to travel past Rising Sun on the East Side. Entrance to Many Clacier, Two Medicine, CuSUN TOURS
